1. Call to Order

At 10:00 am, the Warden called the meeting to order.

Warden Linton welcomed everyone to the meeting. He advised that all County Councillors have signed a voluntary declaration confirming that they have been fully vaccinated for COVID-19; and thanked Council for their leadership and support for staff and Wellingtonpublic health during the pandemic.

The Warden also acknowledged that September 30 is the National Day for Truth and Reconciliation. He thanked the County's Indigenous Advisory Committee led by Colleen Brunelle for their work supporting reconciliation through education and the orange shirt campaign. A plaque has been installed in the Gallery of the Council Chambers recognizing the first ever Indigenous Land Acknowledgement Ceremony held on the December 11, 2020 Warden's Inaugural Meeting. The ceremony included traditional smudging and drumming using indigenous methodology and storytelling.
