J.Salsberg- application before the Committee regarding Maitland Valley Conservation concerns for emergency access - MVCA recommended deferral - provides a sample condition for committee's consideration to cover concerns of MVCA - other comments are in support of application J. Metzger - project has been ongoing for 5-6 years, these applications are next phase; property part of urban boundary expansion A. Alls – confused by MVCA concerns J. Salsberg – access concerns due to past flooding, need ability to access without flooding G. Davidson – flooding often? J. Salsberg – haven't been able to connect with MVCA on this, 2016 flooding event is concern D. McKay – is MVCA ok with access? J. Metzger – spoke with MVCA years ago, their requirement is you need proof of egress, have to maintain elevations – everything already set up for compliance for each lot – everything will be addressed – concern is fringe flood because of old train bed D. McKay – are you agreeable to condition? J. Metzger – conservation would still need to sign off for building permit, their concerns should be covered M. <u>Lloyd</u> – comment – have seen things happen where lots created to avoid site plan, wonder if we need a condition for draining? A. Alls – won't get building permit without it <u>K. Linton</u> – see no issues
