Subject: Preliminary 2022-2031 Ten-Year Plan: Police Services

Background:

This forecast provides a high level view of major budget issues and planned capital investments and serves as a guide for departments in preparing their detailed current year operating and capital budgets. The preliminary corporate ten-year plan will be considered by County Council on November 25, 2021 and the forecast will be updated at the time the budget is approved early in the New Year.

Major Operating Budget Impacts

Staff are in the process of compiling the detailed 2022 operating budgets for each department. Major items reflected in the 2022 Police Operating Budget include the following:

Revenues

- The Community Safety and Policing grant (CSP) that was in place for the suicide prevention/postvention programme as well as human trafficking initiatives is currently set to end over the 2022-2023 period with corresponding reduced contracted expenditures under purchased services with no levy impact
- The revenue to be received in 2022 through the prisoner transport grant has been reduced by \$7,200 based on the 2021 approved grant amount
- In July 2021, Centre Wellington introduced a pilot programme with an enhanced by-law enforcement team focused on parking in the downtown areas. The County is currently in negotiations with Centre Wellington in order to provide the parking fine revenues related to their municipality beginning in 2022. The County has recently upgraded its parking software to facilitate the automation of handheld parking enforcement for by-law enforcement and staff support that aid in the collection of these fines and will be implementing a chargeback for the costs related to parking fine collection on their behalf. These details are still being worked out and the budget will be updated for approval by the board in January.

Expenses

- The province has submitted an OPP policing contract cost estimate for 2022 of \$17,407,413. The cost per property has decreased slightly from \$428.51 in 2021 to \$428.34 in the 2022 estimated billing. Overall, contract costs have increased by \$136,000 or 0.7% from 2021.
- There is an allowance for one new uniformed officer in the 2022 Budget and 2023-2031 Ten-Year Plan that will be added to the contract to keep pace with growth in the County and to address service level requirements. Each additional officer is expected to cost approximately \$180,000 annually (in 2022 dollars). For 2022, the officer is expected to have a start date in July. The 2021 budget allowed for a Sergeant to be added in July for the new CSS unit (Community Safety Services). This officer has yet to be hired, but is included for a full year in the 2022 budget. The

policing contract amounts and additional officers have been incorporated throughout the ten-year plan forecast.

- The provision to account for the annual OPP contract reconciliation remains at \$450,000 in 2022. This amount is included as an offsetting reduction to the transfer payment line. The 2020 reconciliation amount received in October 2021 was just under \$745,000.
- The transfer payment to Safe Communities for \$30,000 and the transfer to Project Lifesaver for \$10,000 have been maintained throughout the 2022-2031 ten-year plan.
- Debt charges for the Rockwood Police detachment matured in 2021 resulting in a reduction to this line of \$175,800 in 2022, which was partially offset by a reduction in development charge funding of \$93,000 for the growth portion of the debt.

Capital Budget Forecast

In accordance with the Capital Budget and Long Term Financing Policy, the list of capital works includes those initiatives that have a long term benefit to the corporation and whose capital cost is at least \$25,000. Projected capital spending includes:

- Equipment related capital expenses include the replacement of the radar detection devices in 2027 and the replacement of the Rockwood detachment generator in 2031. Equipment capital purchases are funded from the General Capital reserve
- Lifecycle replacements at the Rockwood detachment continue with \$800,000 budgeted over the ten years. Staff will evaluate timing and budgets as projects identified in the later years of the forecast move closer to present time.
- Teviotdale detachment furniture replacements originally scheduled for 2022 pushed to 2023 and staff will review the need for replacements again in the 2023 budget process. Interior upgrades (flooring and paint) and security camera replacement are scheduled 2029.
- Aboyne detachment includes interior upgrades (flooring and paint) in 2025, a rehabilitation of the air-handling units in 2026, furniture replacements in 2027, plumbing replacements and HVAC control system in 2029 and elevator modernization in 2030.
- Facility-related projects total \$1.5 million over the forecast and are funded through the Property reserve.

The detailed 2022 operating budget and revised ten-year plan will be presented to the Board in January. Attached to the report is the current proposed ten-year operating budget and ten-year capital budget for Police Services.

Recommendation:

That the preliminary 2022-2031 Police Services capital budget forecast and major operating budget impacts as set out in this report be endorsed and forwarded to the Administration, Finance and Human Resources Committee for inclusion in the County of Wellington's Preliminary Ten-Year Plan.

Executive Summary

Crime Unit

On October 14th, 2021 the Wellington County Crime Unit initiated a criminal investigation involving a \$300,000 load theft from a local trucking company. The suspect used a stolen tractor trailer and fraudulent documents to obtain a load of 11 Skyjack lifts and other products. An OPP Twitter post helped to identify a suspect and GPS tracking software lead police to an area to search.

A coordinated effort between insurance investigators, the Halton Regional Police Service, the Sûrete du Quebec, Chambly Police Service and Saint Jerome Police Service, resulted in the recovery of 8 of the stolen Skyjacks in Quebec. The suspect has been linked to other thefts in Ontario and charges are anticipated.



The Crime Unit is investigating 9 sexual assault incidents reported in the month of October. Some of these are historical in nature and involve multiple victims. In the most of these cases the offender was known to the victim.

In October 2021 a Preliminary Hearing began for the GEMIN Homicide. Investigators play an important role in the court process and are adapting to the new process of "virtual court", which allows police and civilian witnesses to testify remotely through video teleconferencing.

Community Street Crime Unit


In October of 2021, the Community Street Crime Unit has welcomed two new members to the Team. The new Unit Supervisor, A/D/Sgt. McGough comes from Perth County. She has been an employee with the OPP for 13 years, with 6 years of experience in a Detective role. South Wellington also has a

uniform member on a temporary assignment with the Unit. The Unit is focused, and committed to combating the drug, and property crime issues, and concerns in Wellington County.

In the month of October two unit members completed Warrant Service Entry Training giving them the skills and abilities to assist the team with warrant executions. This month another member will be attending the Physical Surveillance Techniques Course. Over the next couple months there will be further training opportunities for the new members of the team to give them further skills and abilities to assist them with their investigations and their new role as a Detective Constable.

Throughout the past month, Wellington CSCU assisted Dufferin County CSCU with a drug trafficking investigation which identified a second male suspect who was residing in South Wellington. On October 29th, 2021, this investigation concluded with two search warrants being executed and three persons being arrested, and charged with multiple drug trafficking charges. One of the search warrants was executed in South Wellington. As a result of this investigation police have seized 482 grams of cocaine, 1254 OxyContin Pills, \$16,995 in Canadian currency, two high-end vehicles and other property related to drug trafficking.

Overnight on October 26th to 27th a suspect targeted the Downtown core of Mount Forest, and slashed the tires on over 30 different motor vehicles. CSCU has taken over the lead investigative role for this investigation. CSCU partnered with Uniform patrol, the Community Response Unit, Media Relations, and Forensic Identification Services to investigate all leads to identify the suspect, and pursue criminal charges.



Over the past month the Team has been working on a number of drug related investigations in multiple towns and areas throughout the County to combat our ongoing drug issues. As well as continuing to investigate drug overdoses and other property crime occurrences.

Automated Licence Plate Reader (A.L.P.R)

The A.L.P.R. cruiser is currently being utilized daily in Wellington County. Recently the Ministry of Transportation rectified the issues with the data being uploaded to the ALPR system that was causing inaccurate positive hits. These data issues pertained to the extension of Driver's Licence and Permit Validation for vehicles due to the COVID-19 pandemic. With these changes the ALPR system is now fully operational and officers have once again begun using it for enforcement.

The Black Cats have now been deployed to 55 different locations in 2021. This data is also being used to target specific complaint locations from members of the community.

ATV Patrol

ATV patrols for the season have now ended, however the ATV's are fully operational and available for use during calls for service.

Marine Patrol

Proactive Marine Patrols in the county have ended for the 2021 Season. During the course of the season Wellington OPP Marine Operators conducted approximately 191 hours of marine patrols on Puslinch Lake, Guelph Lake, Belwood Lake and Conestoga Lake.

Community Events

The Wellington County Traffic Management Unit in conjunction with the various uniform platoons participated in the "Operation Impact/Thanksgiving Long Weekend" Traffic Safety Initiative from Friday, October 8th to Monday, October 11th. Officers from TMU, CSS and Uniform Platoons engaged in high visibility patrols on Wellington County roadways. Officers targeted the "Big 4" Offences of Aggressive Driving/Speeding, Impaired Driving, Seatbelt Usage, and Distracted Driving. During the course of the initial two weeks officers laid the following charges:

- 81 Speeding
- 3 Fail to Wear Seatbelt
- 3 Distracted Driving
- 21 Hazardous Moving Violation
- 2 Impaired Operation of a Conveyance



Community Response

The Wellington County Community Response Unit (CRU) responded to a total of 53 calls for service during the month of October. The CRU was again actively clearing outstanding warrants for the County resulting in six arrests being made. The CRU also assisted the Community Street Crime Unit in the Town of Mount Forest conducting proactive patrols after multiple motor vehicle tires were slashed.

The CRU also completed proactive patrols in Mount Forest resulting in eight criminal charges being laid for various Criminal Code violations including Flight from Police and Weapons related offences. An arrest warrant is being obtained and further active patrols are being made to apprehend the suspect.

CRU members continue to conduct foot patrol as well as RIDE spot checks throughout the County.


Media

Report Summary

Our story for this month: COVID-19, personnel changes, winter is coming and new Collision Reporting Centre.

Wellington County OPP is still feeling the effects of the COVID-19 pandemic as noted in this report by Sergeant Vallier. The court process is still being conducted via ZOOM as the courts are slowly reopening. On top of that, Detachment members must complete mandatory screening when they arrive for duty and anyone entering the building must complete a COVID-19 screening form before being allowed entry. Life does seem to be returning to normal, but there is a lot of change and additional safety protocols in place that have added to the Detachment workload.

Personnel changes are abound as is normal within Wellington County. Many of our officers are given the opportunity for temporary promotional assignments within and outside Wellington County. This results in many personnel changes. This month alone we had A/D/Sgt. McGough join us from Perth County, PC Draves took over as the Auxiliary liaison officer and we had expected the return of A/S/Sgt. Caren Ashmore to her role as the A/D/Sgt. for the Crime Unit, but her assignment was extended and A/D/Sgt. Jennifer Foley stayed on as the Crime Unit supervisor. Although all this movement creates quite the workload for our administrative staff, we take it as a compliment and a testament to the fine job our officers do here in Wellington County. Their efforts and their professionalism are noticed and rewarded with promotional opportunities.

As noted by Inspector Richardson, winter is coming and it is time to prepare. Safety is always our number one priority and it is worth noting again, get your vehicles prepared for winter driving. That means making sure your vehicle is up to operational standards, placing winter tires on your vehicle and adjusting your driving and driving habits to match the road conditions. Set that alarm a few minutes earlier and give yourself time to arrive at your destination safely.

This month also saw the implementation of a Collision Reporting Centre here in Wellington County. Wellington County residents can now attend the Centre Wellington Operations Centre to report motor vehicle collisions. This will allow frontline officers to remain on proactive patrol and attend emergency calls for service in a more timely fashion. Minor vehicle collisions can now be cleared off the roadway quickly allowing for better traffic flow and reducing the chances of secondary collisions. Although it does add to the administrative workload, it is well worth it, as frontline officers are no longer tied up investigating minor motor vehicle collisions and they are readily available for emergency situations.



Calls for Service

A noticeable reduction was observed in 2020 due to the Covid-19 pandemic. With recent re-openings of businesses and facilities as well as relaxed Covid-19 restrictions it is anticipated that levels will return to near-normal.


Current Calls for Service trends are above the 2020 results and an anticipated 18% increase in calls for service is expected over 2020.



Violent Crime

Violent Crime continues to trend higher, however reductions appear to be continuing since. These reductions may be the result of the Covid-19 pandemic and a projected decrease in violent crime of 1% is expected.


Current and projected trends appear to be line with 2020 results.



Property Crime

Property Crime continues to decrease likely in part because of the Covid-19 pandemic. Current trends appear to be following the 2020 results however the projected increase over 2020 is anticipated to be approximately 14% overall.


It remains possible that 2021 Property Crime could see a reduction over 2020 based on the current trend.



Drug Crime

Drug Crime has continued to trend downward since 2017 with noticeable reductions in 2019 and 2020. Current trends appear to be following the 2020 results however the projected increase over 2020 anticipated to be approximately 3% overall.

If recent trends continue Drug Crime could see a reduction in 2021.



Criminal Traffic Offences

Like Drug Crime, Criminal Traffic has also been trending downward since 2017 also with noticeable reductions in 2019 and 2020. Current trends appear to be following the 2020 results and a projected decrease from 2020 is anticipated at approximately 8% overall.


If current trends continue Criminal Traffic will see a reduction in 2021.



Traffic Related Occurrences


An 18% reduction was observed in traffic occurrences from 2019 to 2020, however year to date traffic occurrences continue to surpass the 2020 total.

If the current trend continues an increase of 13% in traffic related occurrences is anticipated over 2020.



Motor Vehicle Collisions


Similar to all other traffic occurrences, an 18% reduction in vehicle collisions was observed from 2019 to 2020. Year to date 2021 collisions appear to be in line with previous years and it is anticipated that the year will end with a possible 18% increase in collisions over 2020.



Big 4 Traffic (Impaired Operation - Distracted Driving - Seatbelts - Speeding)

'Big 4' traffic offences decreased 41% from 2019 to 2020. The greater portion of this reduction appears to be due to decreases in speeding offences that are likely the result of Covid-19 restrictions. The reductions seen in 2020 and 2021 YTD have greatly affected any predictive analysis and forecasting.

Increases are being observed as Covid-19 restrictions are lifted and confidence in the control of the virus returns.


