**Subject:** **Summary of Disposed Vehicles and Equipment 2021**

### Background:

As per the County's Purchasing Procedures, the Manager of Purchasing and Risk Management, shall from time-to-time, obtain from the department heads' itemized inventories of all unusable, obsolete, worn-out, disused or scrapped goods which are surplus to the needs of the County. If such goods can be used by another department they shall be made available to that department. If such goods cannot be used for the purposes of the County, the Manager in consultation with the user department, shall sell or dispose of the goods by public auction, tender, or request for quotation, or whichever method is in the best interest of the County.
