April 2022

From the Detachment Commander

The months seem to be passing quickly, and the past several weeks have continued to be very busy for officers here in the County of Wellington. Frontline officers continue to work diligently to ensure the residents in the County of Wellington receive quality service while meeting their policing needs.


Officers recently dealt with a very difficult fatal motor vehicle collision involving a school bus with several children on board and a second vehicle driven by a teacher from the same school. The officers engaged resources immediately, so that within 30 minutes of the collision, mental health clinicians were on scene to assist with the children and to prevent further traumatization. Officers worked closely with the affected school as well as the Upper Grand schoolboard to ensure that everyone was given time to process and to grieve the traumatic event. Providing supports in these types of incidents is a key component to assisting victims. I would like to take this opportunity to, on behalf of the entire detachment, express my heartfelt condolences to the family, friends, and the entire school community affected by this tragic accident. We will continue to follow up with all of those impacted to ensure that we are doing all that we can to assist them and to support them as they grieve this heartbreaking loss.

With the nicer weather approaching, along with fewer COVID-19 restrictions, we will most likely see an increase in traffic through the County of Wellington. As we approach the May long weekend, we will continue to focus our efforts on promoting traffic and boating safety. All members will be working tirelessly, utilizing both education and enforcement in an effort to make the County of Wellington's roadways and waterways as safe as possible this coming summer season.

Crime

Crime Unit

Supervisor: Acting Detective Sergeant Jennifer Foley

In April 2022 Provincial Constable Jennifer Osborne began a temporary assignment with the Wellington County Crime Unit. Jennifer has been a member of the OPP for six years. Jennifer began her policing career in Perth County and came to Wellington County in 2019. Jennifer is an experienced front line patrol officer who has specialized training in interviewing victims of trauma. Jennifer has an interest in expanding her investigative skills in major crimes. We welcome her to the Unit!

One mandate of the Crime Unit is to monitor high risk offenders and parolees who are being released into the community. The OPP works closely with Probation & Parole Services to ensure that offenders have appropriate supervision and reporting requirements, and are abiding by release conditions. This includes monitoring persons on the Ontario Sex Offender Registry (OSOR) who reside within Wellington County. The OSOR requires people convicted of various sexual offences to register certain information with their local police service. The OPP will not disclose the names, address or any personal information of persons registered on the OSOR, but police officers have access to this information to assist in maintaining community safety. Police services are also permitted to use information from the OSOR to prevent and solves crimes of a sexual nature.

Community Street Crime Unit

This month the Wellington CSCU members were very fortunate to be offered training opportunities that have not been available to them during COVID. The training they received is job based and the new skills are an asset for their position.

CSCU is actively engaged in drug trafficking investigations that are linked to property crimes.

Throughout the month, members conducted follow up for ongoing property crime occurrences, including break and enters, motor vehicle thefts, trailer thefts and high value mischiefs that occurred across the County. As well as actively involved in linking multi-jurisdictional theft occurrences with neighbouring police services and detachments.

In April, CSCU assisted the Child Sexual Exploitation Unit which is a Provincial Unit involved in investigating sexual offences against children. CSCU assisted in locating and arresting the offender.

The Black Cats have been deployed to 13 locations in 2022. This data is being used to target specific complaint locations from members of the community or those identified internally.

Notable Incidents

Wellington County OPP, including the Traffic Management Unit, participated in the annual Easter Long Weekend seatbelt campaign. This initiative was province wide and Wellington County topped West Region stats with 43 charges for seatbelt violations over a period of four days.

Traffic Management members were busy in April conducting commercial vehicle enforcement. During a safety blitz, TMU conducted four commercial vehicle inspections, taking two unfit vehicles off the roads. 10 charges were laid, and eight warnings issued for minor violations. Further, a TMU inspector attended another safety blitz for commercial vehicles where a total of 14 level I inspections were completed, taking eight unfit vehicles off the road. 49 charges were laid, and three warnings issued. Planning is underway for local commercial vehicle enforcement over the next months.

Marine Patrol

A 2022 Marine Operations Plan has been developed to ensure coverage on the waterways for the 2022 boating season. Several special events have been identified and new partnerships have been developed. Safe boating literature has been ordered to provide education to the public on changes to boating regulations and safe operating practices.

Traffic Management is engaging stake holders such as the Ministry of Natural Resources and Grand River Conservation Authority on marine operations for this season.


Community Safety Zones

The Traffic Management Unit are preparing for nine new Community Safety Zones. Community engagement, education and enforcement will be crucial to their implementation.

Collision Reporting Centre

Wellington County OPP as a whole saw a decrease in the number of collisions from March 2022 to April 2022, the Collision Reporting Centre reported a 36% increase in the number of collisions they investigated. This increase is a welcome sign that the workload for frontline officers is being directed to the Collision Reporting Centre, thus allowing officers to focus on priority calls and proactive policing. Members of the public are also benefiting from this as they no longer have to wait at the scene of a collision when officers are busy attending to other calls for service.


The CRU Unit is gearing up for and getting excited about the upcoming seasonal events. In April many of our members attending training courses including our annual Block Training, ATV - all terrain vehicle course, and a bicycle operator course. This will provide some additional educational opportunities and ways that the CRU unit can engage with the public at events, and in their general patrol duties. We hope to have a few more of the members trained on our OPP Bicycles in the next few months – so keep an eye out for them doing patrols on 2 wheels over the summer.

Our members also attended the launch of Project Lockdown, alongside Crime Stoppers, at the Stone Road Mall. It was a great opportunity to engage with folks and help educate them on ways to protect themselves against the theft of motor vehicles in their communities.

Our members attended numerous calls for service, and began with some enforcement at the Quarry over the Easter long weekend. Trespassers to these locations is an ongoing problem after hours, and when these parks are closed. Adventures can lead to tragic endings and enforcement and education are part of the CRU's efforts.

Planning is underway for quite a few events starting to fill up the spring calendar as we anticipate a very busy season.





Safe Communities Wellington County

Continuing on with the Drop the Labels Presentation Series, the second of the presentations took place at The Grove Hub in Palmerston talking about the importance of cyber safety and what harassment means. We partnered with the Wellington County OPP and The Grove to bring this presentation to the youth of Minto, as well as virtually to youth across Wellington County. Further, our Mental Health Action Group has created a survey series focusing on Eating Disorders to determine the best course of action going forward on what strategies and tactics to implement to educate residents of Wellington County about the prevalence of eating disorders in our communities.

Auxiliary Unit

All of our active members completed their annual block training this month. Our monthly meeting featured a visit from the OPP Healthy Workplace Team (HWT). Covid has been a strain on several members of the unit both personally, professionally, and through their volunteer commitment to the OPP. This reminder of the support services available through the OPP was very valuable and it was great to be able to connect face to face with members from the HWT. They also passed along a number of calming and relaxation techniques that could be used in stressful situations both in and out of uniform.

The unit participated in a couple of community events this month. Our members assisted at the return of the Rockwood Easter Egg Hunt. The egg hunt was very well attended by the community. We also connected with the Centre Wellington Food bank for a food drive at Freshco in Fergus. There were almost two full van loads of food and over \$800 in donations collected during the six hours we were in attendance. Jackie Andrews from the food bank was appreciative as always for our participation and she took the time to pass along letters of thanks to our members who attended.

Crime Stoppers

Sarah Bowers-Peter, Program Coordinator CSGW

Crime Stoppers Guelph Wellington (CSGW) focused on Auto Theft Awareness in April, hosting Project Lockdown on April 21, 2022 at Stone Road Mall in Guelph. This event saw 50 faraday key fob pouches given to motorists free of charge. Members from Wellington County OPP and Guelph Police Service provided their support and amplified the message of reducing the chance of auto theft. These pouches can also be purchased by going to www.csgw.tips . A small portion of the proceeds goes to CSGW.

Anti-Black and Anti-Indigenous Racism training is an ongoing priority for the CSGW Board. A two-hour training session geared to Crime Stoppers was delivered by Dr. Rai Reece of Toronto Metropolitan University (formerly Ryerson University).


The Human Trafficking and Sexual Assault grants concluded in March, however there are two grants that CSGW has applied for or contributed to, and we look forward to hearing of the outcome of these applications. The human trafficking and sexual assault videos that wrapped up the grants are available for viewing on the CSGW YouTube channel.

May is Mulch Month with the Mount Forest Mulch Sale at Young's Home Hardware in Mount Forest on May 7th and the month-long partnership with JL's Home Hardware's three Guelph locations. Fundraising is a crucial component of Crime Stoppers to pay Tipster rewards and to operate the program.

Commissioner's Letters & St. John Award

Detective Constable Jennifer Osborne #14559

Detective Constable Jennifer Osborne received a call to assist ambulance with an elderly male party that was VSA. DC OSBORNE arrived before paramedics to an apartment in Fergus. She entered the apartment to an elderly male that had collapsed, unconscious, unresponsive and not breathing. The son of the elderly male was attempting to perform CPR. DC OSBORNE began CPR and compressions on the male party immediately. DC OSBORNE did this for more than two minutes until paramedics arrived. EMS crew were able to establish a pulse shortly after arrival and the male was transported immediately to a local hospital. DC OSBORNE attended for a different call for service later in the evening to that same local hospital, and inquired to the elderly male's status. The male was stable, and alive and receiving additional treatment.







Calls for Service


Thus far in 2022, year to date calls for service have increased by 14% over the same period last year with April 2022 showing a 3% decrease over April 2021.

Calls for service appear to be gradually returning to normal levels.









Violent Crime

Violent Crime continues trending lower since 2018. This reduction may be in part due to the Covid-19 pandemic however there is a projected decrease in violent crime for 2022.

Year to date violent crime has decreased 23% over the same period last year with March 2022 showing a 28% decrease over March 2021 and April 2022 currently showing a 57% decrease over April 2021.

Property Crime

Property Crime had an observable decrease in occurrences in 2021 that was likely due to the Covid-19 pandemic. Current trends appear to project an increase over 2021.

Year to date property crime has stabilized (no change) over the same period last year with March 2022 showing a 15% decrease over March 2021 and April 2022 currently showing a 33% decrease over April 2021.

Drug Crime *

Drug Crime has continues to trend downward. Current trends appear to be following the 2021 results however a projected increase over 2022 is anticipated.

Year to date drug crime has decreased 43% over the same period last year with March 2022 showing a 25% increase in over March 2021 and April 2022 currently showing a 71% decrease over April 2021.

Criminal Traffic Offences

Like Drug Crime, Criminal Traffic has also been trending lower. Current trends appear to be following the 2021 results however a projected increase over 2022 is anticipated.

Year to date criminal traffic occurrences have increased 16% over the same period last year with March 2022 showing a 9% decrease over March 2021 and April currently showing a 46% increase over April 2021.

Traffic Related Occurrences

Although reductions were observed in traffic occurrences during 2020 and 2021 current trends appear to project an increase over 2021.

Year to date traffic occurrences have increased 2% over the same period last year with March 2022 showing a 9% reduction in occurrences over March 2021 and April 2022 currently showing a 13% reduction over April 2021.

Motor Vehicle Collisions


Similar to all other traffic occurrences, reductions in vehicle collisions were enjoyed during 2020 and 2021 however again, it appears these occurrences are returning to near-normal levels. An increase over 2021 is anticipated.

Year to date collisions have increased 37% over the same period last year with March 2022 showing a 28% increase in collisions over March 2021 and April 2022 currently showing a 2% increase over April 2021.


Big 4 Traffic (Impaired Operation – Distracted Driving – Seatbelts – Speeding)


Reductions in Big 4 traffic offences were observed during 2020 with increases seen in 2021 as the Covid-19 pandemic progressed. An increase over 2021 is anticipated.

Year to date Big 4 offences have decreased 28% over the same period last year with February 2022 showing a 49% decrease in over February 2021. No further data has been available for this category since February 2022.



Wellington County OPP also wants to remind the public to lock the doors on their vehicles both overnight and during the day. It does not take long to enter your vehicle and remove your belongings. It is much easier and quicker to lock your car doors then it is to make a police report about your lost items. The five seconds it takes to look your vehicle doors can save you 30 minutes to an hour at a police station, not to mention the aggravation of your belongings being taken from you.

We are looking forward to seeing members of the public attending the many community events being organized across the County of Wellington and we hope everyone can enjoy these events safely.
