Many employers within the Wellington region have shown commitment to creating diverse, inclusive, and equitable work environments. However, without the tools to visibly demonstrate an equitable, diverse, and inclusive workplace, many employers may inadvertently alienate local youth of colour, women, and those who identify as part of the LGBTQIA2S+ community. Without a bridge between local marginalized youth and industries eager to focus on EDI initiatives, youth may defer from a specific industry or to geographically distance themselves from the local workforce. The central goal of our Let Me See Me project is help employers who seek to offer equitable, diverse, and inclusive work environments, and provide them with the tools to showcase to local marginalized youth that they can be assured to see themselves and their values reflected within a particular workplace or industry. We strive to help employers go #BeyondValues by assisting them with the education, tools, and resources they need to exhibit safe, inclusive, and equitable workplaces for LGBTQIA2S+ and BIPOC youth within our community.

Another central goal of Let Me See Me is to create a sturdy foundation that will enable CEC to continue to provide ongoing resources and networks for employers to make their workforces more accessible, inclusive, diverse, and equitable. The CEC hopes to use this project to reach a wide range of youth in Wellington County, and to help guide youth towards a career path where they feel seen, heard, accepted, and more specifically, one in which they can thrive in. This grant would support the substantial resources required to uplift youth voices as essential components towards meaningful action, materials to help educate and empower employers to go #BeyondValues, and would enable our organization to partner with a larger pool of local employers who are committed to making youth feel welcome, seen, safe, and a celebrated part of our local workforce landscape.

Let Me See Me has three core stages: (1) research and identification, (2) development and resources, and (3) building momentum towards community action. CEC seeks the opportunity to receive funding for the second stage of the project: development and resources.

Currently within stage 1, our organization has began gathering data re: existing local employer initiatives towards EDI, as well as capturing data, feedback, and testimonials from marginalized youth who are between 0-5 years away from entering the workforce. Incorporating youth voices and experiences is essential to identifying both visible and invisible barriers. Identifying the reasons in which youth may feel insecure, underrepresented, alienated by specific areas of the local workforce is key to creating EDI tools and programming that can help to eliminate these difficult lived experiences. Local employers will also be surveyed and invited to meet with the CEC and local youth in focus groups to identify gaps, a lack of tools, or existing EDI initiatives. Youth in secondary school will be compensated with receiving their volunteer hours. The CEC also seeks to develop another form of youth compensation for those who dedicate their time to the research portion of the initiative.

The development stage seeks to use the above data to create tools/resources that employers can adopt to go #BeyondValues. The CEC will utilize this information to pinpoint specific gaps that can be addressed through programming, outreach, workshops, webinars, and toolkits. Based off the data collected, and by placing youth voices at the centre, the CEC is seeking funding to develop toolkits for local businesses that embody EDI values, processes, and actions that can be put into place to bridge a gap between the youth and the workforce. The CEC will then select 5-10 local employers to work with directly to implement EDI initiatives within this businesses or organizations. In short, funding from Wellington County would enable the CEC to create resources to help bring the lived realities of marginalized youth into a sphere were employers can turn said resources into building momentum

towards meaningful community action.

Materials/resources needed to help local employers go #BeyondValues, and make youth voices an essential part of shaping local EDI action, confronting systematic barriers, and make youth feel seen in their local workforce include:

-Promotional materials for project

-Physical resources for workplaces, or toolkits (posters, EDI certificates, flyers/educational resources for staff, guides for creating stronger EDI initiatives)

-Workshops (virtual or in person) facilitated by CEC to help educate employers

-Creating video workplace tours with a focus on EDI and #BeyondValues that will be hosted on our Career Exploration Portal

-Virtual training resources that can be shared to school boards, employers, and community partners

The CEC understands that EDI workplace and community initiatives are not monolithic. At the heart of this project is a commitment to generating a youth and employer-focused EDI initiate from an authentic standpoint. As both an ally and a facilitator of a youth-centred EDI initiative, the CEC seeks to implement transparency and honesty in its data collection, youth participation, and youth feedback from workshops, resources, and career events.

The final phase of the project will include distributing these recourses to local employers and educators, as well as planning and putting on a career or job event. The invitations for the event will be exclusive to youth in marginalized groups, CEC community partners, and will feature the 5-10 employers that have worked together with the CEC to enhance their EDI initiatives in all stages of recruitment, hiring, and community engagement process. Employers featured will be from a diverse range of industries. Featured employers, educators, and local industries will also be those who are committed to adapting the philosophies and practises aimed towards helping youth to feel safe, included, and reflected within a specific workplace.

A central goal of Let Me See Me is to create a foundation that will enable the CEC to continue to provide ongoing resources and networks for employers to make their workforces more accessible, inclusive, diverse, and equitable. CEC hopes to use this project to reach a wide range of youth in Wellington County, and to help them towards a career path where they feel seen, heard, accepted, and one in which they can thrive in. CEC recognizes that barriers founded within the contexts of race, gender, sexuality, religion, and culture are part of deep rooted, systematic inequities within Canada. However, through this project, CEC seeks to help illuminate, identify, confront, and begin to work towards tearing down walls created by the historical processes of inequity.

At a local level, our organization hopes to give BIPOC and LGTBTQIA2S+ youth the assurance that their voices are heard, valid, and an important part of their futures. Big Brothers Big Sisters of Guelph (BBBSG) provides no-cost mentoring programs to over 600 atpromise youth in Guelph and the communities of Aberfoyle, Ariss, Eramosa, Morriston, Puslinch, and Rockwood. These youth are experiencing (or have experienced) adversities that affect their healthy development, and they are in need of an additional caring and consistent adult role model in their lives. BBBSG staff recruit, interview and train prospective adult volunteers to serve as mentors for these atpromise youth, seeking to build strong Developmental Relationships. These two-way relationships empower the children and youth to build healthy lifestyles, stay in school, connect with their peers, engage in their community, and reach their full potential. Mentoring programs are delivered in one-toone and group-based arrangements, both in the community and in more than 40 local schools, where mentors meet with their mentees on school property with the support/supervision of an assigned school liaison. All mentors are trained on the Big Brothers Big Sisters Theory of Change, which articulates the programs' goals and activities, with expected outcomes for the child being improved social emotional competence, improved mental health and wellbeing, and increased educational engagement and employment readiness.

BBBSG is seeking support from the County of Wellington for our "Play On!" Group Mentoring Program. This program provides mentoring support for at-promise girls by matching them in groups with a pair of volunteers aged 18-25 who are intentionally recruited based on the needs of the community's young people. These volunteers meet with their mentees once a week on school grounds to engage them in the program materials that focus on teaching youth how to maintain an active lifestyle, understand healthy eating, build mental wellness through positive self-image perception and beneficial relationships, and enhance school connectedness. As one of our suites of School-Based Group Programs, the Play On! curriculum incorporates engaging activities designed to increase social emotional competence, mental health and wellbeing, as well as educational engagement and employment readiness in accordance with the BBBS Theory of Change. The key to the success of our programs is the relationship that develops between the youths and their mentors. Play On! was created by our agency to address a need in our community: health-focused mentoring solutions for at-promise girls aged 10-12 who were previously unserved by our programs. In the 2022/23 school year, we plan to serve 130-170 kids through Play On!.

The success of our School-Based Mentoring programs is evaluated through surveys that measure the short and long-term effects of participating in mentoring programs. The 2021-22 province-wide evaluation findings show that mentored children: are less likely to bully, fight, and express anger towards their peers; have an increased desire to be in school and increased chances for success in school; experience higher achievement in school subjects and improved classroom participation; maintain a decreased number of unexcused absences from school, especially on mentoring days; experience improved social skills, motivation, self-esteem, and self-confidence; and become interested in volunteerism and are more likely to be a mentor in the future. The survey evaluating youth in our School-Based Mentoring groups showed that: 98% believe they make good life choices, 96% report being happy, and 87% have strong social networks.

Our Play On! Mentoring Program provides much-needed support for the at-risk girls and young women of Guelph by giving them consistent and supportive developmental mentoring relationships. During the

pandemic, our agency and volunteer mentors never stopped providing mentoring services to youth. We had to pivot and evolve our mentoring programs by creating virtual and hybrid opportunities to ensure that our services remained accessible to any young person in the community who needed them. This year, our Site-Based Mentoring Programs have fully returned to an in-person model; returning to schools in the community as they were before the pandemic. Since Play On! will continue to take place on school grounds and during school hours, we are fortunate to also have the support of the school staff and school boards to host us. We have formal memorandums of understanding with both the Catholic and Public school boards that endorse Big Brothers Big Sisters mentoring programming on school property.

The County of Wellington has long supported our mentoring programs for youth and their support was especially apricated over the past few years as our community, staff, volunteers and young people navigated the challenges of the pandemic. To support the Play On! Group Mentoring Program within our School-Based mentoring suite, we are requesting \$2,000 from the County of Wellington.

The 2023 Elora Festival will offer free community outreach concerts during the month of July. By expanding to more public, outdoor venues, we will reach more community members and visitors. We recognize that not all audiences will feel comfortable with indoor performances. By bringing music into the outdoors, we will be able to re-engage our existing audiences, while also attracting new and more diverse audiences. It will also ensure economic accessibility for those not able to afford ticketed concerts.

This grant will be used to cover a portion of the artist fees for these concerts, which will take place at outdoor locations throughout downtown Elora and a new expansion into Fergus. The concerts will be promoted through social media and community partners, profiling the County of Wellington's support. We will make a deliberate effort, through our community partnerships, to facilitate people from proportionately disadvantaged populations in attending the concerts, including adults with (dis)abilities and seniors in long-term care.

Our free Festival outreach concerts have traditionally been limited to indoor Evensong and Sunday church services at St John's Elora. The 2022 Elora Festival saw tremendous success in starting to grow our free outreach concerts, with 11 occasions that reached a combined 1,060 people who were able to enjoy the music free of charge. They also had the added benefit of drawing people to the downtown core in Elora, helping to support the local businesses. With support from the County of Wellington, we will be able to continue growing this program.

Over its 43-year history, the Festival has evolved from a very small music festival (originally called the "Three Centuries Festival") that focused on 300 years of strictly classical music, with very few guest artists. By 2019 (the last pre-pandemic year), the Festival had grown into nearly 40 concerts and events held over three weekends in July, welcoming approximately 7,000 choral enthusiasts to Centre Wellington. The 2020 and 2021 Festivals were held online. 2022 returned to an in-person Festival that showcased 70 guest artists and had 4,384 attendees.

The Elora Festival has continued to operate throughout the pandemic and is very well-versed in working within Public Health guidelines. We have no concerns about adhering to these guidelines for our events.

Strong Start Charitable Organization is a registered Canadian charity established in 2001, that has helped over 51,000 children learn to read. The flagship Letters, Sounds and Words™ program is designed to provide one-on-one support with trained volunteers at the child's school over a 10-week period. Our literacy intervention program targets children in Year 2 Kindergarten, Grade 1 and 2 who have been identified by their teachers as behind in essential early reading/literacy skills. It has also been adapted for English Language Learners to Grade 4 and has proven highly successful in supporting a growing newcomer population.

This program consists of 4 strands:

Letters: learning to identify and name upper- and lower-case letters Sounds: learning to identify and understand the sounds of letters Words: learning to recognize 26 high frequency words by sight Building Words: learning to blend sounds to decode and build words

The \$2,000 County of Wellington Community Grant will go directly towards helping more young children learn foundational literacy skills. The Letters, Sounds and Words program is delivered in Fergus, Elora, Mount Forest, Rockwood, Arthur, and Erin in Wellington County. The funding will help train volunteers to become Volunteer Coaches, provide their manuals and consumable learning materials for the children to use in the program. As illustrated in the chart below, COVID-19 directly affected the number of children in Wellington County who received help in this program, and we are looking to return to prepandemic numbers and growth. Because of COVID-19, the need for early intervention in a child's literacy journey is more important than ever.

*Due to COVID-19 restrictions, children experienced on-line learning and Volunteer Coaches were unable to provide in-person support.

The National Strategy for Early Learning Report states one out of four Canadian children entering grade one is already significantly behind their peers. The Letters, Sounds and Words program is an evidence-based, high impact response to this need. Our assessment data demonstrates that 95% of the children enrolled in the program made considerable, excellent, or outstanding gains in their early literacy skills.

For every \$1 that is invested in early education, the return to society is \$3-\$17, when considering its

proven links to poverty, crime, high school graduation rates, employment rates and civic engagement.

This Grant will enable the children of Wellington County to receive one-on-one support by trained Volunteer Coaches, which will not only develop their literacy skills but also enhance their social development.



"North Wellington Benevolent Fund"

The funds requested with this application will be used to continue offering our "North Wellington Benevolent Fund". These funds are used for unique circumstances to assist people of low income in the townships of Wellington North, Minto and Mapleton. These funds support families and individuals with specific expenses when no other funding support is available to them.

Through our Community Outreach Services, we have various programs intended to help those who are struggling financially in our community. We have already in place, a program to help with emergency rent and/or utility arrears. We have a free transportation program for essential appointments. We also have specific funds for grocery gift cards for those dealing with food insecurity; winter coats, boots and other winter wear purchases for children and youth; backpacks filled with necessary school supplies for the start of the school year; and free swim passes for families to use at township pools during the summer season.

The funds for the above programs have very specific purposes. However, we have noticed through our outreach work, the need for a special fund- one which is more inclusive and can be used as a reserve to help with exceptional costs people living on a low income may encounter.

Our North Wellington Benevolent Fund is used for filling in service gaps in terms of financial support. For example, ODSP has limits on their benefits. A client receiving ODSP may only be able to use a portion of their benefits but there is a remaining fee. We use this fund to offset that cost for some.

Sometimes it is referrals from other workers because their agency does not have the funding to cover the cost of their client's request. They will turn to us to see if it is something we can support. For example, Family and Children's Services workers needing mattresses or beds for children coming into custody. Grandparents/kinships are not always able to afford all the costs associated with taking the children.

A furnace repair is another recent example of when we relied on these funds. We recognize that an unanticipated cost like this can cause financial hardship for those who have low or fixed incomes. Such a repair could mean that groceries will be limited, or a rent payment may be delayed.

With all our programs, this one included, our goal is to do what we can to keep individuals/families financially stable while working alongside them in developing a plan for success moving forward. We strive to give everyone in our community the opportunity to succeed, and we want to do this in a way that promotes self-sufficiency in the future.

The continued presence of the virus and rising costs of living have impacted us all, especially our lowincome clients. We continue to receive referrals from other agencies. People in our community reach out to us when they are not sure where to get the help they need. We feel there is a demand to keep this fund going. If our agency can help a little bit with an unexpected expense, we can at the very least alleviate some financial stress. These residents will have more room for other living expenses, which will result in housing stability, and this is beneficial to our townships and County.

Scientists in School is seeking \$2,000 in funding for a project that will provide 6 complimentary Kindergarten to Grade 8 STEM classroom workshops (6 x \$300/classroom workshop), either virtual or on-site, to schools across Wellington County in 2023, plus outreach funds (\$200). This will directly impact 140 vulnerable students and their 6 teachers by providing hands-on, curriculum-aligned STEM workshop programming.

Three school years of ongoing disruptions in education have happened at a crucial development time for children. It is well-documented that early gaps in learning if left unaddressed, shift children's future success trajectories. A publication released through the Scholars Commons at Wilfrid Laurier University summarized the consequences of school closures in relation to the future and lifetime earnings of affected students. It states that: "Each month of skill loss is predicted to cause a ~1% drop in lifetime earnings for affected cohorts and is estimated to decrease the national income by 0.5 percent per year, which would translate to a GDP loss for Canada of 1.6 trillion CAD." With 50 to 70% of future jobs predicted to be in STEM-related occupations, the need for accessible STEM enrichment education in Canada is more critical than ever, not just for the children, but for the overall prosperity of the County of Wellington.

140+ local children and youth will receive curriculum-aligned workshop experiences, which, depending on the topic chosen by their teacher, will include hands-on discoveries about subjects such as the impact of energy on our daily lives, engineering concepts required to build solid structures, the value of simple machines in making work easier, the importance of plants and soils in our environment, design concepts to build circuits and explore electricity, or producing DNA replica models to explore genetic diversity, among many other experiments and activities that are designed to inspire, fascinate and engage students through science.

Scientists in School was founded in 1989 as a grassroots outreach project and has grown into a leading education enrichment charity dedicated to sparking children's interest in science, technology, engineering and math (STEM) through engaging, hands-on workshops. In our 33-year history, we have inspired over 10 million young scientists and have been inspiring thousands of students through classroom workshops in the Upper Grand District School Board and the Wellington Catholic District School Board since 1999. Last school year, we delivered 95 virtual classroom workshops to 14 schools across the County of Wellington, impacting over 2,200 local students. We hope to increase our impact even further this school year.

Our mission is to ignite scientific curiosity in children so that they question intelligently, learn through discovery, connect scientific knowledge to their world, are excited about STEM, and have their interest in those fields piqued. The best proof of the value of our classroom workshops is often found in post-workshop testimonials from teachers, such as this, from an educator with the Upper Grand District School Board: "The Scientists in School workshop fully engaged all the students in my class! Kids actually started clapping and cheering when they saw the effects of the static electricity experiment. Then they were so engaged in preparing their circuits with conductive tape, that you could hear a pin drop as they concentrated. Even though the presenter was virtual and we were in the classroom, students interacted with our scientist as she encouraged their ideas and questions. I also was surprised with a wonderful package of follow-up activities that I will definitely use with my class as we continue to

investigate and learn about electricity. This is even helping me gain a better understanding of how to support student science inquiry and experimentation. Thank you for a wonderful workshop and I can't wait until we can do another one!"





If successful in obtaining this grant funding, the Aberfoyle Farmers' Market would like to purchase folding tables and canopy tents. We often have vendors that require tables and/or tents, but unfortunately we do not have the equipment to be able provide this service to them. Obtaining folding tables (at a cost of \$80+HST each) and canopy tents (at a cost \$345+HST each) would introduce a new (and ongoing) revenue stream for the market, as we would intend to rent these items to vendors at an additional weekly fee. We estimate that we could charge \$10-20 per day for a table rental and \$25 to \$40 for a canopy rental. These funds would give us greater flexibility in our annual budget, even if only to cover inflationary price increases from our suppliers for things like rent, software subscriptions, etc. Alternatively, these rental fees could be leveraged for additional advertising, or helping cover the costs of a potential dinner box series (i.e. packaging, payment processing fees, coupons, etc.). There are a number of different ways the market could benefit from an additional revenue stream like this. While weekly rental income might be a relatively small amount given the above estimated rates and the number of tents & canopies we could buy with \$2,000, we work diligently to stretch every dollar and maximize the benefit to the market, our vendors and our customers! Obtaining this community grant funding would help us in maintaining a central access point to local goods and fresh foods in the Puslinch community. Through our seasonal operations, the market supports the local economy by giving farmers and producers a low-cost, low-risk sales outlet to connect with customers. We strive to connect the community with local growers and businesses, and any grant proceeds from the County of Wellington will allow us to continue doing so.

Hospice Wellington is requesting funding to support the development and expansion of our music therapy program, which benefits our palliative patients, their families, and our caregivers. A hospice music therapy program brings a distinctive and essential range of supports to those at the end of their lives. Music is a primary and universal connecting agent - when utilized by an accredited professional, it is a form of therapy which can uniquely surround patients and families at a critical time, touching shared elements of culture, memory, emotion, and spirit. Music therapy also has clinically proven physiological benefits; research increasingly demonstrates that music therapy can address pain and symptom management by tapping into the principles of endorphin release and pain gate control theory, among other physiological responses. The beneficiaries of this program funding would include hospice care patients, their loved ones, and the various team members (staff and volunteers) caring for the patient(s) and loved ones.

In 2021, Hospice Wellington engaged the services of accredited music therapist, Catherine Manning. Music therapists actively support the socio-emotional, physiological and spiritual wellbeing of individuals at end-of-life. It was hoped that through the expansion of this therapeutic modality, a greater number of patients and loved ones would benefit from the opportunity to experience the aesthetic and uniquely humanizing effects of music in the clinical setting. Through individualized clinical interventions using guitar, harp, piano and voice, our clients have the opportunity to experience symptom support through enhanced relaxation and decreased anxiety; they have the opportunity to create pieces of legacy to leave for loved ones (eg. audio/video original songs); they can engage in anticipatory grief work within a supportive therapeutic modality. Outcomes at the unit level include enhanced holistic care through transforming the care environment for patients, loved ones and staff into a space of aesthetic beauty. Catherine also offers hospice-based music therapy in the rural areas of Wellington County, extending the supports to those in the community.

According to therapist Kathy Kortes-Miller, "Music therapy is closely aligned with the philosophy and vision of hospice palliative care because it concentrates on bringing forth the person-hood of the individual who is dying. Music can elicit memories, emotion and decrease anxiety and experiences of pain. Music therapy can also support a connection between the music, the memories, and social supports important to a person who is dying." It is important that we look at ways to strengthen, deepen and broaden our clinical services. By integrating a clinical Music Therapist into Hospice Wellington to work with our residents and bereaved clients, we are engaging a wide variety of people in community-based arts creation. Our clients will both create and be given an important channel for emotions. By expanding our current music therapy program, we anticipate that our music therapy program will be able to continue past its first year, and that we will be able to support this valuable therapeutic work at a level of 3 days/week, throughout the 2023 calendar year.



Our outreach initiatives have included:

- Quilts made for the patients of Homewood Heath Centre in Guelph specifically for the residential Eating Disorders Program. This is a new and ongoing project for EVQ.

- Quilts of Valour. Quilts were and are being created to benefit veterans in the community. One in particular is being used as a raffle/auction item that will benefit numerous veterans through Branch 442. This is a continuing project.

- Longtime supporter of the Erin Fall Fair as a sponsor in the Homecrafts division.

- Annually prepare and donate gift bags of toiletries and small items for women and men in need as well as donating to the food bank. These are distributed though East Wellington Community Services (EWCS).

HopeSpring Cancer Support Centre is a community-based non-profit organization dedicated to helping anyone impacted by cancer, whether directly as an individual, or their families, caregivers, and others who reside within the Waterloo-Wellington Region and Grey-Bruce Counties. With over 25 years of impact in the community, we have an established presence and effective programming that helps over 5000 members a year who are affected by cancer diagnosis.

Per Cancer Care Ontario (https://www.cancercareontario.ca/en/cancerplan) 1 in every 2 Ontarians are going to develop cancer at some point in their life, with cancer being the leading single cause of death in Ontario making up 29.3% of deaths. A more positive statistic is that the cancer mortality rate has been declining since 1983 and accelerating in its decline since 2001. This means more pepole are living post diagnosis, which means an increasing number of people that require support. HopeSpring offers these individuals a variety of support for different needs, helping those in need free of charge and in accessible formats. One of our key program offerings is our support groups that have provided multiple benefits to thousands of individuals.

Our Support Groups are a safe space for those facing cancer to connect with one another, share experiences, and receive advice and guidance on taking care of themselves. We currently hold our support groups via Zoom and offer a variety of specified groups such as Women's, Men's, Ovarian, Caregiver and Peer support. On average our support groups have an annual attendance of over 1000. Survey data shows a moderate to significant increase in overall wellbeing, specifically mental wellbeing.

Our Peer support program aims to support anyone who is affected by cancer using reflective listening. Peer Support will help members feel connected to their communities and assist in reducing the effects of loneliness, social isolation and identify high risk members. It will provide internal and external referral, suggest community events to participate, and it will be responsible for establishing and maintaining regular conversation through zoom or telephone with assigned members for the purpose of providing them with company, companionship, and a connection with their community.

One of our highlight achievements in the last few years has been our resilience and adaptability during the pandemic. At the beginning of 2020 we were quick to adapt our programming to fully remote and virtual formats, having only a one-week delay in between our delivery formats. As many of our members desperately need our services this was crucial in ensuring both the mental and physical well-being of our members, especially during such an unprecedented and difficult time. In this transition to virtual format, we have also been able to break through barriers, mainly geographic, in providing service to a larger number of people who previously would have been difficult or impossible to access our services. Our plan into 2023 is to begin transitioning to a hybrid system where members and the community can participate based on their level of comfort, offering both in person and virtual options for all of our programming, which will also allow for greater flexibility and adaptability if/when facing COVID-19 restrictions.

With the transition to online programming, we have been able to have greater impact on surrounding communities including Wellington County. Since online programming became our main method of delivering services in the beginning of 2020, HopeSpring has seen a significant increase in the number of attendees and members from regions other than Waterloo, Kitchener and Cambridge including Wellington County.

Seed, Soil, and Spirit School is an Indigenous, Black, and racialized women-run educational organization building thriving, healthier communities by uplifting the histories, living stories, and relationships of plant medicine, nutrition, and land stewardship from Indigenous, Diasporic, and decolonial perspectives.

We offer accessible programming on nutrition, traditional medicine, and cultural wellness led by healthcare providers and traditional knowledge keepers. Our programs are open to all and centre the experiences and needs of those most impacted by colonialism and forced displacement. We prioritize these communities because we understand that they are disproportionately affected by a lack of access to care, intergenerational trauma, healthy foods, and severance from culture. Additionally, the presented solutions often remove people from their traditional wellness practices.

Our goal is to help build thriving, healthier communities rooted within our cultures. We believe revitalizing our traditional knowledge systems can help us heal the traumas of colonization and displacement and become healthier and stronger, creating a more robust and holistic model of community-led, preventative care.

We have hosted nearly 250 students, primarily Black, Indigenous and racialized people local to Wellington County and the surrounding regions. Since the program's inception in 2020, we have operated online due to the pandemic. Our goal is to transition from running solely online to offering inperson programs at our half-acre learning centre at Ignatius Farm now that COVID-19 restrictions have eased.

Funding will be used to cover part of a coordinator's salary to conduct the consultation, offer honorariums for community members, and provide supplies and refreshments for consultation sessions. In addition, this consultation will engage key community organizations and leaders who will collaboratively help plan and design the learning space. Through this, we will identify the most immediate and long-term programming needs of community members and cross-organizational collaborations.



UCHS services under-resourced companion animal populations in a geographically and demographically diverse region. Disparate communities, lack of resources for feral population management, long distances between clients and veterinary health care providers, and varying socioeconomic levels render basic veterinary care provided by the UCHS vital to maintaining the health and wellbeing of companion animals across the region. Wellington County is predominantly rural and extends across several communities, with diverse human populations and varying needs for their pets. UCHS also services the animals of individuals who travel from neighbouring communities, such as Guelph, Rockwood, Elora, Fergus, Halton Hills, Erin, Milton, Brampton, and Mississauga. The UCHS seeks to provide care in a manner that motivates suburban and rural Canadians to engage more fully with their companion animals and surrounding community of animal lovers.

UCHS is currently seeking funding for sustainable delivery of evidence-based services to improve health outcomes for underserved animal populations in under-resourced settings. We are focused on adoptions and adoption preparation expenses, feral population management, as well as vaccination and microchipping clinics, with an eye toward recovering lost time and expanding operations in the near future.

1) Adoption preparation takes place within the shelter setting and begins with intake of community animals either provided to the shelter by residents, surrendered by owners, or by neighboring municipal organizations. These animals are provided with necessary medical care to improve and stabilize their health and to prepare them for the rigors that follow. The next step is to provide vaccinations, antiparasitic treatments, microchips, and the respective spay or neuter surgery. Finally, our animals are socialized to ensure that they will be ready to integrate into their new forever homes. These items are all basic requirements for our animals before they can even be considered for adoption. The adoptions themselves are carried out by volunteers and staff both within the shelter setting as well as in community settings. The program's ability to intake and adopt out healthy, happy, and well socialized animals is directly affected by the difficulty in sourcing necessary medical resources, venues, and human facilitators. This grant will both directly and indirectly ensure that each animal is provided with the highest quality medical treatment, vaccinations, parasite remediation, social engagement, enrichment activities, and the time necessary to assess potential future forever homes and potential future owners.

2) UCHS vaccination and microchipping clinics provide a low-cost opportunity for owners to obtain necessary preventative care for their companion animals in a local community setting. The clinics are provided in partnership with local businesses and organizations; they bring local animal lovers together, creating community engagement with the public. Local partners include Premier Equipment Ltd., Pet Valu, etc. Detailed owner and companion animal data is collected at each clinic. Additional financial flexibility will allow UCHS to more effectively collate and analyze this data to better understand regional challenges. With appropriate funding, these types of clinics can be scaled up and offered more frequently across a broader geographic area.

Population management via reduction of the number of potential homeless community cats and dogs can have a significant effect on reducing Wellington County's community burdens in the future. The need to spay and neuter incoming animals is also paramount, as it increases the quality of life of the animals and eliminates the possibility of these specific animals contributing to large regional feral populations. An important element to note is integration of new animals into their forever homes. If a pet arrives at a home well socialized, happy, and healthy, it significantly increases the likelihood that a successful

integration will take place. The fewer adoptions there are that cause serious trouble, the fewer people there will be looking to dispense with their new pet. The continued engagement of the public with UCHS ensures our ability to provide support for companion animals in Wellington County. Finally, Vaccination and microchipping clinics diffuse the potential for outbreaks and feral populations in the community. All of these services generate significant positive outcomes for Wellington County, while simultaneously eliminating remediation costs. For the foregoing reasons, UCHS believes that this grant would be of benefit to both Wellington County and the Humane Society.



This request is to support the activation of ECFTA's new acoustic pavilion in 2023. We have secured funding for and are building an acoustic pavilion in November 2022 (six months delayed from original timeline, due to COVID and supply chain challenges). The 2023 activation of this pavilion will include live art-based performances by the Elora Community Theatre, Riverfest Elora, and the Elora Singers. ECFTA's 2-acre greenspace is becoming a vibrant gathering space, central to downtown Elora, that encourages community connection, creativity, acknowledgement of local history, and active transportation. By hosting a series of performances through the summer and fall of 2023, residents will have the opportunity to experience all that we have to offer. The County of Wellington will be prominently recognized throughout the season with on-site signage and social media.

2023 will build on the successes of 2022, which were partially realized despite the pavilion construction delays. In 2022, we pivoted to erecting an event tent. This tent hosted 4,431 people for a wide variety of community events and performances, over the course of four months. In 2023, we estimate reaching close to 7,000 people.

Founded in 2002 & located in an 1856 heritage schoolhouse, ECFTA is a not-for-profit charity that promotes, teaches and nourishes the creation and appreciation of the arts through educational programs, exhibitions, events and workshops. We are a community hub for arts and culture regionally. Galleries feature the work of 568+ artists annually, displaying Canadian works to 16,000+ visitors year-round. 2,700 participants engaged in ECFTA art classes in the last year (2,200 free of charge). We are home to 12 long-term tenants in the arts and education sectors.

ECFTA has continued to operate throughout the pandemic and is very well-versed in working within Public Health guidelines. We have no concerns about adhering to these guidelines for outdoor events.


Sensational Elora – Festival of the Senses has been in existence since 2008. We have evolved through several changes but, we have always maintained our mission to combat food insecurity in Centre Wellington. To the end of 2019 (before all events were cancelled for the pandemic) we have donated over \$130,000 to the Centre Wellington Food Bank and the high school breakfast program. We run fundraising events throughout the year including "Film on a Plate", a unique event at our local theatre that combines a movie with food and beverages that relate to the theme of the movie. We also run "Fabulous Fergus Pub Night", basically a progressive dinner through three pubs in Fergus. Our main events are focused on Thanksgiving weekend. We run a free family event (accepting donations for the Food Bank) on the Saturday of Thanksgiving called "Pumpkin Day". On the Monday of that weekend, we run our "Sensational Soup-Off" where participants can buy "Empty Bowls" donated by local potters and enjoy up to 18 soups in their new bowls, prepared by volunteer amateur, youth, and professional soup makers, each vying for the "Super Souper of the Year" prize in their category. This event is our major fund raiser of the year.

In recent years, we have added jazz shows at Elora Centre for the Arts as well as "Monster March", another free family event where whole families join us for a parade through Elora dressed in their best Halloween costumes. For 2022, we added a new feature - a "Wicked Wagons" contest to this nonmotorized parade. Our participation for 2022 far exceeded previous years with an estimated 1000 participants and onlookers. And finally, we added "Monster Month". Thanks to a fund-raising initiative, we were able to purchase and repair "The Twilight Zoo" and develop a monstermonth.ca website. We became an umbrella operation for many community organizations running monster month themed events throughout the month of October (including Wellington County Museum and Archives) and we have become so successful that the Elora BIA has allocated significant funding to help us grow. We attract thousands of visitors to Elora each October, and we continue to grow. As a matter of interest, during the pandemic, Sensational Elora installed our Twilight Zoo sculptures on all the businesses in town at no cost while many of these small businesses were struggling with the lockdowns. As a result, we were awarded the "Community Social Responsibility Award" by the Chamber of Commerce. Unfortunately, the pandemic also had a huge negative impact on our non-Monster Month events. For two years we could not hold any of these events, so we weren't able to contribute to the Food Bank and, at the same time our two major corporate sponsors changed their sponsorship focus and have dropped us. As a result, we are very limited in what we can do to expand our outreach and increase our annual contribution to the Food Bank and the high school breakfast program. We do not have plans to use the funding for specific events, instead we hope to improve our capacity for additional marketing and cover some of our operating expenses, which would allow us the ability to increase our contributions to help address the ever-increasing food insecurity issue in our community.

Please note, re your request for an operating budget: Sensational Elora events run throughout the year. Each event relies on fund-raising and sponsorship, so we budget for each event separately. Also, due to the incredible success of Monster Month, we are forced to find new storage for the "Twilight Zoo" sculptures, so we are keeping Monster Month revenue separate to combine with fund-raising to build a new facility. Although we do not have a single operating budget for Sensational Elora events, we do have a guideline that our bank account must remain above a "rainy day" level. Unfortunately, 2 years of pandemic with zero revenue and standard expenses, our bank account was virtually cleaned out. That being said, we do have budgets for each event which we would be happy to share with you if you wish. Please let me know.

Colonel John Bain Maclean, the founder of Maclean's magazine, The Financial Post and Maclean-Hunter publishers, was born and raised in the small village of Crieff, Ontario, where his father was the minister at Knox Presbyterian Church. After establishing a successful career in Toronto, he returned to Crieff in 1916, living in the old church manse which became his country home. He later bought adjacent farmland (300 acres) and created an industrious farm with a dairy herd, pigs, grain fields, orchards and reforested land. When he died in 1950 he left 250 acres of the farm and its buildings to the Presbyterian Church in Canada, along with money invested to maintain the properties and in the mid 1970's the denomination founded a retreat centre. Today, Crieff Hills welcomes individuals and groups of all faiths and traditions for both day programs and overnight visits.

Guests come from the surrounding area, from across the province, and even from across the country to attend events, making it an important asset for tourism for the region as it draws more than a thousand people to the county each year. In a quickly changing world it is also a place that preserves and enlivens history where guests can experience an early settler log home (1845), eat in the stone schoolhouse (1874), or stay in an old Ontario style home (1872). Arts organizations, community groups, churches and schools, as well as individual writers, artists, and students all benefit from the opportunities that are available. A positive impact is created in the local economy through food producers and area tradespeople. The local environment benefits from the recent work of adding a new orchard and pollinator gardens, adopting permaculture practices, animal grazing of invasive species and composting.

As elsewhere in the hospitality sector, Crieff Hills found that the pandemic created many challenges, but also new opportunities for growth. In the spring of 2021, we recovered the tradition of making maple syrup from our maple trees. Mainly led by volunteers, we tapped almost 50 trees in 2022, boiling syrup over a small setup with an open fire and aluminum pans. The chef finished and bottled the syrup, which we now sell to guests when they visit, generating income for our work as a retreat centre.

A gift from Wellington County would be used to support our maple syrup production as we purchase a proper evaporator. We can purchase a small unit for approximately \$3000 and use it inside the old stone barn foundations for protection. Volunteers will continue to lead this program, aided by staff when they are available. Guests on the property during the season will have opportunities to meet with and watch the gathering (which we do by hand) and boiling of sap. It would be wonderful to have a more efficient process and we expect better quality syrup with proper equipment as well.

Focus on Nature would like to continue bringing our successful nature photography workshops to schools located in the County of Wellington. With funding, we will be able to deliver 10 workshops for free to low-income students in grades 3 - 6. With more and more children losing interest in their local natural environments, research is seeing a heightened number of children struggling with mental and physical health problems. It is necessary for communities to inspire their youth to explore the outdoors. With funding, Focus on Nature will be able to reach children in low-income areas who otherwise may not experience positive guided activities such as Focus on Nature workshops.

Focus on Nature workshops cost \$330 which poses a barrier to participation in many schools, especially those in low-income areas. Our goal is to eliminate as many barriers as possible so that all students are provided the opportunity to participate in our workshops. Students from all communities will be able to improve both their mental and physical health through a positive experience with nature photography. This funding will allow us to reach a more diverse group of students and provide valuable opportunities for young people to appreciate their local natural environment.

In encouraging young people to get outside and discover nature in their neighborhood, the short-term impacts include increasing children's appreciation for nature, leading to a desire to be outside and engage with their natural environment. In addition, students will gain self-confidence, enhanced artistic expression, and enhanced awareness of their own creative potential. To measure this impact, students are provided with an online questionnaire after each workshop that includes quantitative and qualitative questions regarding these outcomes. Overall, this initiative will help to reduce the long-term consequences of a growing disconnect between young people and their natural surroundings.

We hope that by connecting young people back to nature, they will be inspired to become future environmental stewards, giving back to their community through conservationism and adaptation.





My name is Carl Gray and I am President of the South Wellington Community Lions Club and part of our Trade Tracks committee. We are a new, growing, Lions club focusing on the needs of all communities in Wellington County, south of Highway 109 (hence the name South Wellington). We have been honoured to be allowed to establish the Ennotville Library as our home base.

We believe that there is a growing and under fulfilled need for tradespersons in our local area and wider areas beyond. We would like to create a TRADE TRACKS A TRADES SHOWCASE AND FORUM that we hope would allow people to see what a vast myriad of skills tradespeople celebrate. We would like this showcase to help make a connection between tradespeople and the community. We believe that people need to see, especially young people, that there is an opportunity for a great career as a tradesperson. There are 140 + registered trades in the province of Ontario and we believe the whole community needs to be made aware of that fact.

While there seems to be a great number of scholarships and the like. As well as student loans available for students moving on to institutes of higher learning it seems there is little in the way of scholarships or government financial support for young people entering the trades. This event will help our club perpetuate and grow the scholarship program we began last year. We believe with recognition the equitability will come.

At the time I am writing this letter the Ontario government is hosting "Level Up" trades showcases in five locations across the province. They are concentrating their efforts on the Large urban areas of each part of the province, Toronto, London, Ottawa, Sudbury and Thunder Bay. While this is a beginning, like many community initiatives we believe that the movement needs to begin at the grassroots level. Right here in our Community. We are going to create a 2-day event Friday and Saturday, May 5th and 6th,2023 at the Centre Wellington Community Sports Plex. We would like to have all 144 trades represented. On Friday our main focus would be to have the students from the Wellington Dufferin area come to see this eye-opening display of opportunities for them. we want them to have a chance to talk with people in the trades, people in the varied educational institutions, the government and trades organizations that help them get to the end goal of a rewarding career. We hope to have speakers to explain to them how to navigate their path.

Saturday, we envision an opportunity for the tradespeople to network among themselves and also with the community. The adult community can see that there is opportunity as well for a great career as a tradesperson. The community needs to see how false the many misconceptions of the value of a trade as a career are. Tradespeople make the world work. Their talents and skills rival those of anyone. A large portion of tradespeople make a substantial 6 figure salary and as an apprentice, they make a living the day they start their apprenticeship. While university is definitely a way to "pursue your passion" trades are certainly an equal and valuable path for others.

We are going to put together a program (directory) for this event. The program advertising will be sold on a part-of-a-page basis. Each ad bought will give the buyer a chance to set up a display in our showcase. These programs will be distributed at the event with advertising, a map of the layout as the centrefold and a directory of each participant that helped our first annual Trade Tracks show become a huge success. I personally think with a little help from the trades we can showcase very close to all 144 trades. That is our challenge and goal as a committee and Lions club.
