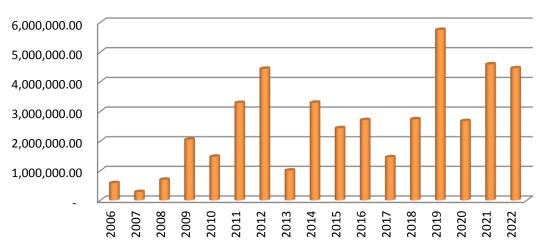

Background:

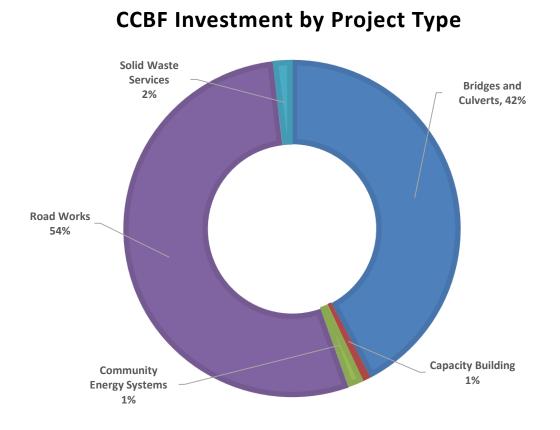
The agreement for the transfer of Canada Community Building Fund revenues (formerly, Federal Gas Tax) under the New Deal for Cities and Communities was originally signed in 2005. The purpose of these funds is to invest in environmentally sustainable municipal infrastructure. In 2014, the County entered into a new agreement with the Association of Municipalities of Ontario (AMO) for the Transfer of Federal Funds. The agreement expands on the eligible categories and requires that municipalities clearly demonstrate that projects funded with federal dollars be prioritized based on an asset management framework.

Since its inception in 2005 the County has received \$47,124,987 in Federal funding and invested \$43,938,380 in local infrastructure, solid waste services, capacity building and community energy systems. The difference plus interest earned sits in the Reserve Fund (\$5,382,865) and is reflected as deferred revenue (to be used for future projects) on the County's financial statements. The 2023 budget includes \$3.0 million investments in roads, bridges and culverts with continued investment of \$30.2 million over the next nine years.

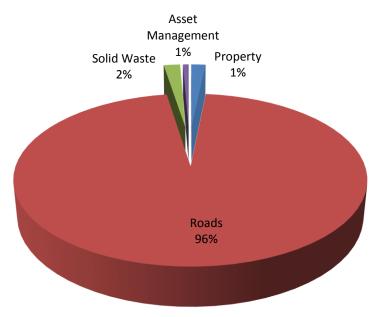
The following charts summarize the County's spending by year, project type and department. The projects funded to date are detailed in Schedule A.
