Subject: Tender Award – Creekbank Bridge Rehabilitation

Background:

Staff recently issued Project No. CW2023-031 a tender for the rehabilitation of the Creekbank Bridge located between Wellington Road 8 and Mapleton Twelfth Line.

The work includes the removal and replacement of existing concrete barriers and curbs (approx. 46.4 linear metres), bridge deck top waterproofing, asphalt paving (approx. 670 tonnes), steel beam guiderail and end treatment installation (approx. 200 linear metres), and other miscellaneous concrete repairs. The project will require a full road closure.

On Thursday March 16, 2023, ten (10) submissions were received from prequalified bridge and culvert contractors as follows, with pricing shown exclusive of HST @ 13%.

Additional professional fees are estimated at \$50,000.00.
