Subject: Tender Award – Wellington Road 109 Rehabilitation

### **Background:**

Staff recently issued Project No. CW2023-013 a tender for asphalt rehabilitation on Wellington Road 109 between Sideroad 13 and the Dufferin County boundary.

The work provides for the renewal of 6 km of WR109. Three culverts will be replaced, and the roadway base will be reconstructed by use of cold-in-place recycling with expanded asphalt material to be topped with 50mm of hot mix asphalt and pavement markings.

On Tuesday April 4, seven (7) submissions were received from contractors as follows, with pricing shown exclusive of HST @ 13%.

Additional professional fees are estimated at \$60,000.00.
