Subject:	23 Gordon Street, Guelph – Funding Update

## **Background:**

This report is a follow-up to the 23 Gordon Street Project Update report that was approved by Social Services Committee on March 13, 2024.

In January 2024, staff reported that the County had received confirmation of \$3,941,000 in secured capital funding for the project. Since that time, staff continued to work with funding partners to secure additional funding to complete the project. On March 25, 2024, the County received a conditional letter of commitment in the amount of \$2,627,696 from an unnamed funding source. Due to communication embargos put in place by funding partners, County staff are unable to announce specific funding sources at this time.

The attached Capital Project Expenditure and Financing Schedule lays out the total project costs for the additional transitional housing units and emergency shelter beds at 23 Gordon Street, Guelph, including the construction management contract that was awarded to Demikon Construction up to a Guaranteed Maximum Price of \$4,961,544, subject to an approved funding plan. The funding schedule provides the total amount of funding that has previously been secured and recently committed in order to fully fund the project.

## **Recommendation:**
